1. This invitation for Bid follows the General Procurement Notice for this Project that appeared in the "ADB Business Opportunities", issue no. **731 posted on 2 July 2008 and later undated in UNDB issue no. 786 on 16 November 2010.**
2. The Royal Government of Cambodia (RGC) has received a grant from the Asian Development Bank (ADB) towards the cost of Strengthening Technical and Vocational Education and Training (STVET) Project and it intends to apply part of the proceeds of this ADB Grant No.0178-CAM to payments under the contract for **The Supply, Delivery and Installation of Automotive Workshop Equipment for NTTI Complex and 5 RTCs.**
3. The Ministry of Labour and Vocational Training as Executing Agency (EA) now invites sealed bids from eligible Bidders for the supply, delivery and installation of Automotive Workshop Equipment for NTTI Complex and 5 RTCs.
4. **International Competitive Bidding (ICB)** will be conducted in accordance with ADB's Single-Stage: One-Envelope procedure and is open to all Bidders from eligible sources countries.
5. Interested eligible Bidders may obtain further information from Strengthening Technical and Vocational Education and Training (STVET) Project and inspect the Bidding Document at the address given below from **8:00am -12:00 noon and 14:00pm-17:00pm (local time) on all working days from 4 April 2013 to 20 May 2013.**

The Bidding Document, in the English language, may be purchased by interested Bidders on the submission of a written application to the address given below and upon payment of a **non-refundable fee USD70 or its equivalent in Cambodian Riel being Riel 280,000.**The method of payment will be made by either Cashier's Check or Cash. The Bidding Documents will be sent by post or collected in person at the discretion of the bidder. No liability will be accepted for loss or late delivery.

Bids must be delivered to the address below at or before **2:30PM on 21 May 2013.** All bids shall be accompanied by a **Bid Security in the amount of USD, in the total amount of USD 16,000.** Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at **2:30 PM on 21 May 2013.**
8. Ministry of Labour and Vocational Training (MLVT) will not be responsible for any cost or expenses incurred by Bidders in connection with the preparation or delivery if bid.
9. In the comparison of Bids, ADB's Domestic Preference Scheme will not be applied in accordance with the provisions stipulated in the instructions to Bidders.
